We welcome research papers of original work and of substantial nature in all areas of mathematics written in Latex or AMS tex. Only papers submitted in English will be considered for publication. The submission of a paper implies that the paper is not being considered for publication by any other journal. After the manuscript is accepted author must send the Latex file of the final version by e-mail to *choudary@cwu.edu* and copy to *fbhatti@lums.edu.pk*. After the paper is accepted for publication, a hard copy of the accepted paper will be required. This hard copy must be typed on one side of the paper.

Title: Titles should be concise and informative according to the nature of theory and research. Titles are often used in information retrieval systems.

Author names and affiliations: The author(s) name(s) should come first, present the author(s) affiliation addresses below the names. Indicate all affiliations with a lower-case superscript letter. Provide the full mailing address of each affiliation, including city and country name, and the e-mail address of each author.

Corresponding author: Clearly indicate who is going to handle correspondence with editorial board at all stages of refereeing and publication, also post-publication.

Abstract: The abstract should state briefly the purpose of the research, the principal results and major conclusions.

Keywords: Immediately after the abstract, provide a maximum of 10 keywords, using British spelling and avoiding general and plural terms and multiple concepts (avoid, for example, 'and', 'of'). *These keywords will be used for indexing purposes.*

AMS Mathematics Subject Classification followed by keywords.

References: References are important and must be numbered consecutively in alphabetical order of the author's name and are designed by number in square brackets in the text. The general format is indicated below:

For a book:

For a paper from a journal:

C. E. Chidume, E. U. Ofoedu and H. Zegeye, Strong and Weak Convergence theorem for Asymptotically nonexpensive mapping, J.Math. Anal. Appl 280 (2003) 364-374

For a contribution to a contributed volume:

S. Suantai, Matrix Transformation of some vector valued sequence spaces, Lecture Note in Pure and Applied Mathematics, Marcel Dekker, New York - Basel (2000), 489-495.

Every submitted paper will be acknowledged and evaluated by panel of two referees. The editorial board decision should be final regarding rejecting or accepting paper based on the referees' reports. There is no per page charge. Each author will receive 20 reprints of his/her paper free of charge.
